Business and Workforce Development

Getting businesses from Point A to Point B is a **collaborative effort** on the Upper Shore. The USRC provides organizations with resources for success. Working together with Cecil, Kent, and Queen Anne's counties, USRC nurtures the region's physical, economic, and social development. From startups seeking capital to established businesses seeking a new home, USRC's tri-county collaboration makes dreams doable.

Nurturing Our Regional Narrative

The industry landscape on the Upper Shore is diversifying every day. Ample real estate, workforce talent, and a keen business focus inspire industries to up their game on the Upper Shore. On average, over 80% of residents in Cecil, Kent, and Queen Anne's counties work in private industry, with **OVER 1/3** holding bachelor's degrees or higher. Partnering with area businesses and higher education, the Upper Shore keeps skills aligned with the needs of local industries.

USRC Small Business Marketing Grant Pilot Program

A grant program was created to assist "mom & pop shops" located in the downtowns of the Upper Shore region. Small business owners are experts in their business's products but many struggle to make the most of their marketing budgets. With the assistance of a marketing and public relations

firm, this program was structured to educate business owners about marketing, create a marketing plan specific to their business needs, and provide seed money to implement their plan. This program was key during the COVID-19 pandemic, which heightened its impact. By helping small businesses thrive, small downtowns also benefited by drawing more foot traffic to their sidewalks.

The first phase of this program was unveiled in partnership with the Kent County Department of Economic & Tourism Development. The USRC Small Business Marketing Grant pilot program **assisted 14 businesses, representing 39 jobs.** Phase two is expected to begin in FY 2022.

Oyster Harvest Rotational Pilot Program

The Oyster Harvest Rotational Pilot Program is a **four year program** that provides an economic and ecological benefit for the Upper Shore. Commercial watermen represent a **\$5 million industry sector** on Maryland's Eastern Shore. USRC cultivated a partnership with Kent County and Queen Anne's County Commercial Oyster Committees and the Maryland Department of Natural Resources (DNR) to assist small commercial watermen and oyster production. This partnership works to leverage the resources of committees and DNR to create a self-sustaining oyster harvest rotational program in the Upper Shore Region. Approximately **30 million oyster spat** (oyster larvae) have been planted in a prepared, mutually agreed upon, 7-acre section of water in the first year. Funds generated from the project will be used to fund the next iteration of oyster spat planting.



Upper Shore Micro Ag Grant Program

The Upper Shore Micro Ag Grant Program is a collaborative effort, funded and supported by USRC, to assist agribusinesses in Cecil, Kent, and Queen Anne's counties. The USRC, in partnership with the Cecil County Office of Economic Development, the Kent County Economic & Tourism Development, the Queen Anne's County Department of Economic Development, and the Maryland Agriculture & Resource-Based Industry Development Corporation (MARBIDCO) has committed **\$90,000** to **32** agribusinesses across the Upper Shore.

The program aims to improve the regional food system by creating cohesive relationships between the economic development offices and farmers within the Upper Shore Region that promote partnership and resource sharing. The micro-grant program helps rural communities within the Upper Shore access fresh food, ultimately helping to create a vibrant and economically sustainable region.





USRC Farm Incentive Fund Sustaining Futures in Farming



In the three years of this program, the USRC Farm Incentive Fund has **approved 6 grants** totaling **\$31,500**, which leveraged **\$570,000** of MARBIDCO funding for agriculture/rural businesses.


USRC Farm Incentive Fund

USRC partnered with the Maryland Agricultural and Resource-Based Industry Development Corporation (MARBIDCO) to create the USRC Farm Incentive Fund. Designed to incentivize loan requests from food and fiberproducing farms, this program helps farmers meet downpayment requirements and improve the credit quality of their applications. The USRC Farm Incentive Fund provides a **5% equity contribution** towards financing a project funded through a MARBIDCO loan program.

County Specific Initiatives

The USRC strives to boost employment, empower existing businesses, attract new industries, and foster budding agriculture initiatives. Led by a strategic plan for regional success, collaborations with government, education, economic development, businesses, and private citizens are at the core of every project.

As a regional organization for Cecil, Kent and Queen Anne's counties, the USRC supports county initiatives that align with the Upper Shore's regional narrative.



Spotted Lanternfly Workshop -Cecil County

The spotted lanternfly (Lycorma delicatula) is an invasive pest that presents a significant threat to Eastern Shore agriculture, including the grape, tree-fruit, hardwood, and nursery industries, which collectively contribute billions of dollars to Maryland's economy. USRC partnered with the Cecil County University of Maryland Extension Office and the Cecil County Office of Economic Development to provide a 'Lunch and Learn' event regarding the Spotted Lanternfly.

Partnership with Susquehanna Workforce Network- Cecil County

USRC partnered with The Susquehanna Workforce Network (SWN) for two projects.

The first project, USRC and SWN focused on enhancing warehouse/distribution and healthcare careers in Cecil County by supporting entry-level and mid-level workforce training. These two industry sectors comprise nearly 45% of the employment base in Cecil County. The project's primary goals were to i) increase the pipeline of workers and advance worker skills for these industry sectors and ii) increase employment opportunities for area residents.

SWN teamed with Cecil College as the primary training provider for the project. The project proposed **training 11 unemployed or underemployed** Cecil County residents for entry-level training and **5 incumbent workers** for mid-level training in the county's key industries of Warehouse/Distribution or Healthcare. However, the program met with such a demand for mid-level training that **49 employees were trained**, a **980% increase** over projected numbers.

In the second project, SWN targeted unemployed citizens and underemployed workers to help fill workforce pipeline needs in Manufacturing, Transportation/Distribution/Logistics, and Healthcare. SWN provided basic individualized career services, skill upgrades, and occupational training for **21 project participants.** After the training, **71% of participants entered employment**, earning an **average wage of \$19.51** at placement.

Eastern Shore Entrepreneurial Center hotDesks Program - Kent County

USRC continued to provide financial support for the Eastern Shore Entrepreneurial Center's (ESEC) hotDesks program located in Kent County. Kent County Department of Economic & Tourism Development partnered with ESEC to develop a hotDesks location in Chestertown. hotDesk members have access to shared office space, entrepreneur and innovation training, capital for high-growth, scalable startup and growth businesses, and gigabit broadband connectivity.

Agriculture Awareness Day - Queen Anne's County

For multiple years, the USRC has sponsored Queen Anne's County's annual Agriculture Awareness Day. This day-long program educates 7th-grade students on the agricultural sector and agriculture-related career paths in Queen Anne's County. The events are held at the Queen Anne's County 4H Park, and the following agricultural topics were discussed: technology, equipment, crops, aquaculture, nursery, produce, greenhouses, forestry, and farm animals. The program dispels common myths about the agricultural sector and demonstrates the variety of career opportunities present for Queen Anne's County students in this industry.

In 2019, **583 students** attended from four middle schools, accompanied by **25 administrators** and **90 volunteers** from the agriculture community. USRC intends to continue funding this program for future iterations.

Project Bright Future Summit - Queen Anne's and Kent counties

USRC supported and participated in the Project Bright Future Summit, a regional initiative aimed at youth in the community interested in pursuing careers in hospitality, manufacturing, construction, and other trades. The summit aimed to i) create awareness of the excellent career opportunities available to students in the five-county service area (Kent, Queen Anne's, Caroline, Dorchester, and Talbot counties) of Chesapeake College and to ii) increase student participation in Career Technology Education (CTE) programs, Youth Apprenticeships, and Dual Enrollment programs. The program's vision was to create a pipeline of skilled workers to meet the demands of the region's current business base and assist in business retention, expansion, and attraction for the area.



Held on September 25th, 2019, the Project Bright Future Summit promoted middle-skills positions and included a tour of Chesapeake College, a keynote address from Kurt Landgraf, President of Washington College, and a panel discussion featuring Dr. Cliff Coppersmith, President of Chesapeake College; Chris Garvey of Allied Builders and Contractors; Delegate Jeff Ghrist; Alan Stein of Tanglewood Conservancy and the Untangled Minds Foundation; Jeff Smith, MD Department of Labor, Apprenticeship Maryland; and Cody Pine, Washington County Public Schools CTE. Local businesses interested in hiring students were also in attendance. Jack Wilson, Queen Anne's County Commissioner and a voting member of the USRC, emceed the event.



Keeping Growth Smart and Sustainable

The USRC's commitment to the land—and to economic longevity—fuels participation in plans and projects impacting its communities. Whether the topic is business recruitment or broadband development, the Council supports initiatives aligning with its regional narrative. The expansion of area amenities, jobs, and transportation strategies will encourage more residents to work where they live. Infrastructure development creates places that people want to work in, invest in, inhabit, and enjoy.



Cecil County Broadband Expansion Pilot Program

The Cecil County Department of Land Use & Development Services approached USRC to expand broadband in Cecil County through their pilot project called the "Customer Contribution Model." At the time, there were approximately **2,514 homes and businesses** without access to

broadband service. After meeting with three major broadband providers serving the County, a draft financial model (the Customer Contribution Model) was developed to expand service. Specifically, this model uses two sources to fund broadband expansion – the broadband provider and the served customers. Funding assistance was granted by USRC and resulted in providing an additional **31 homes** with broadband access.

Creation of a Datastory for the Upper Shore Region

To assist the region's business attraction efforts, USRC funded a regional Datastory and Datastories for the USRC counties. A Datastory is a sophisticated business attraction and expansion tool that allows users to visualize the region/county's data points through an interactive map.

The Upper Shore Region Datastory was created to answer the fundamental questions of "Who, What, Where, and Why." Individuals and businesses unfamiliar with the area will get a sense of the region and do a deep dive into the data. Each Datastory provides an analytical view of the area's current opportunities and magnitude of possibilities.



The Datastory project also serves as a platform to inform stakeholders of the Upper Shore Region and the public at large about the area's exciting changes. Because the USRC Datastory is an interactive map, it can be tailored to each user's needs.

Kent County Transportation Program

In 2018, the United Way of Kent County conducted a community needs assessment for the county, denoting public transportation as one of the top needs. A Transportation Taskforce, in which USRC participated, was formed to explore transportation management within Kent County and Kent County's connectivity to the robust transportation systems in neighboring Cecil and Queen Anne's counties. The task force recommended hiring and appointing a transportation coordinator to build capacity and improve the current transportation service. In 2020, the Kent County Commissioners voted to create a new Housing and Transportation Coordinator position housed under the purview of the Kent County Local Management Board's Community Plan for Children and Families (LMB).

The USRC is partnering with the LMB to improve the availability and accessibility of current transportation services vital to medical appointments, work, food shopping, and other services. Specifically, USRC funds will assist the Housing and Transportation Coordinator in establishing a Basic Needs Workgroup to continue the work of the United Way's Transportation Taskforce. The Workgroup will guide and address the key findings of the Transportation Taskforce. These findings include a marketing plan to increase usage of existing service, installation of additional signage, and assist employers with establishing a rideshare program.





GIS Circuit Rider Program

USRC recognized that many municipalities on the Eastern Shore do not have the capacity (adequate staffing or time) for GIS-related tasks. Responding to this need for on-site assistance, the USRC joined the Eastern Shore Regional GIS Circuit Rider Program. Through this program, jurisdictions throughout the Upper Shore have access to specialized GIS solutions. Circuit Rider projects may include GIS implementation, web mapping, technical support, data collection, cartographic services, GIS training, data analysis, and task automation.

A robust economic climate **strengthens** neighborhoods, schools, jobs, and the quality of life along the Upper Shore. USRC's partners are economic development innovators, business leaders, and county, regional, state and federal officials collaborating on behalf of the Upper Shore. Their breadth of experience and **diversity** of viewpoints keep our **trajectory** on target.



Cecil Cares is an annual countywide day of service and USRC funds were used to assist advertising efforts, provide lunch for volunteers, purchase basic supplies, support volunteer recognition, and contribute to the Volunteer Cecil site fee. In 2019 and 2020, 250 volunteers served with 26 community organizations to complete 27 projects. Cecil Cares staff and volunteers provided capacitybuilding services for community organizations, including promoting and maintaining Volunteer Cecil, an online volunteer recruitment and matching system.

WKHS (90.5 FM)

USRC provides programming support for WKHS, a non-commercial educational FM radio station owned by the Board of Education of Kent County and run by Kent County High School students. To support students and their voices, the USRC has sponsored this radio station for the past several years.

Cecil College Foundation

The Cecil College Foundation, Inc. is a nonprofit 501(c)3 dedicated to developing financial and other resources to support Cecil College students. The USRC has supported this organization to continue growing the talented workforce present in the region.



USRC, in partnership with local businesses, community members, and Washington College partners, sponsored a Geospatial Discoveries Day Camp introducing 16 regional students, ages 12-16, to satellite imagery, sensors, and geospatial technologies. Campers worked with college interns, faculty, and staff to foster a passion for geospatial technology.

Students experienced the Living Learning Lab, including the Callinectes Research Vessel, AREN kite sensor technology, and drone equipment and demonstrations.

Scenic shoreline, idyllic downtowns, and wide-open spaces **invigorate** recreation within Upper Shore **communities**. The Upper Shore Regional Council strives to amplify attractions, empower existing businesses, and attract new visitors to experience the **vibrancy** of its community.





Cecil County Farm Museum Regional Agriculture Center

The Cecil County Farm Museum (CCFM) was created to preserve and promote the rich agricultural heritage of the northeast portion of Maryland. As the organization has grown, they decided to expand their vision to develop a Regional Agricultural Center. To open a Regional Agricultural Center for students and citizens, the Cecil County Farm Museum needed several infrastructure improvements, including making an ADA-compliant bathroom. USRC was able to provide funding to assist them with this improvement.

Taste of the Eastern Shore

In partnership with the Tri-County Council for the Lower Eastern Shore of Maryland, the Mid-Shore Regional Council, and the Upper Shore Regional Council, Taste of the Eastern Shore is a networking event highlighting local vendors. Over **175** of Maryland's Senators, Delegates, Cabinet Secretaries, staff, and elected officials representing the Eastern Shore are in attendance. Both the 2019 and 2020 events were held at the Graduate Annapolis Hotel.


